## **FREQUENTLY ASKED QUESTIONS ABOUT UNITED ARAB EMIRATES ENTRY VISA**

---

**Q.**

**What documents do I need to provide to obtain this Visa?**

**A.**

You need to provide a clear scanned copy of the bio data page of your passport and a clear standard passport size photograph. The passport of the applicant must be more than six months before the passport expiry date.

---

**Q.**

**How long is this visa valid for?**

**A.**

The bearer of this visa is allowed to stay legally in the United Arab Emirates for upto 30 days after which he either has to exit the Country or contact our office to extend his stay by a further 20 days.

---

**Q.**

**Is this Visa valid for Single or Multiple entry?**

**A.**

This is a Single-Entry visa and expires the moment the visa holder exits from the United Arab Emirates.

---

**Q.**

**Can I get a job with this visa?**

**A.**

This is a Tourist Visa and it is **ILLEGAL** to work in the United Arab Emirates using this visa whether the job you are doing is a paid job or a volunteer job. The United Arab Emirates has an elaborate and straight forward procedure for issuing employment visas. Please note that employment visas in the United Arab Emirates are issued **FREE OF CHARGE** by the specific employer and the employee does not pay anything in order to get this visa. **Q.**

**What is the visa processing time?**

**A.**

After you fill in an application form and make payment via Warri, it will take 48 hours for your visa to be ready.

---

**Q.**

**Can I track my visa application?**

**A.**

Yes, the visa applicant can track the application process at any time by login onto our portal <https://tbldc.travel/-CheckVisaStatus> Just enter the details requested and the system will give you an updated status of your application

---

**Q.**

**Why does a Dubai visa application get rejected?**

**A.**

If your visa application had any typo errors in name, passport number, profession code and other particulars like date of birth, passport issuance and expiry, then the application may get delayed or rejected. If the scanned copies of your passport is blurred, then the UAE immigration may reject or delay the process. A visa application will also be rejected if the validity of the Passport of the applicant is less than Six months. A visa application may also be rejected due national security concerns.

**Q.**

**Will I get a refund if my visa application is rejected**

**A.**

There is NO Refund if a visa application is rejected

---

**Q.**

**Is it easy to get Dubai visa?**

**A.**

Getting a Dubai Visa is very simple if you have all the necessary documents and you correctly fill the visa application form.

**Q.**

**How do I receive the visa?**

**A.**

The Dubai UAE visa is an electronic document and it will be sent to the Visa applicant via any of the following methods:

- Whatsapp
- Messenger
- Telegram
- Email
- The client can directly download the visa from our Portal

The visa applicant must upon receipt of the Visa print it and show it to the Border Control Officer on arrival at the airport in Dubai
